

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to <https://ihbusa.com> and Integrated Holistic Builders LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Integrated Holistic Builders LLC include <https://ihbusa.com> and IHB. The IHB website is a Informational website for a small construction business site. By using the IHB website, you consent to the data practices described in this statement.

Collection of your Personal Information

IHB may collect anonymous demographic information, which is not unique to you, such as your:

- Age
- Gender

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. Sharing Information with Third Parties

All such third parties are prohibited from using your personal information except to provide these services to IHB, and they are required to maintain the confidentiality of your information.

IHB may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on IHB or the site; (b) protect and defend the rights or property of IHB; and/or (c) act under exigent circumstances to protect the personal safety of users of IHB, or the public.

Tracking User Behavior

IHB may keep track of the websites and pages our users visit within IHB, in order to determine what IHB services are the most popular. Automatically Collected Information

Information about your computer hardware and software may be automatically collected by IHB. Security of your Personal Information

We strive to take appropriate security measures to protect against unauthorized access to or alteration of your personal information. Right to Deletion

Subject to certain exceptions set out below, on receipt of a verifiable request from you, we will:

- Delete your personal information from our records; and

- Complete the transaction for which the personal information was collected, fulfill the terms of a written warranty or product recall conducted in accordance with federal law, provide a good or service requested by you, or reasonably anticipated within the context of our ongoing business relationship with you, or otherwise perform a contract between you and us;
- Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity; or prosecute those responsible for that activity;
- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the

- public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
 - Comply with an existing legal obligation; or
 - Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.

Children Under Thirteen

IHB does not knowingly collect personally identifiable information from children under the age of thirteen. If you are under the age of thirteen, you must ask your parent or guardian for permission to use this website.
